<b>Supply Price</b>	Your rate for electricity purchases will be a fixed price of \$0.0885 per kWh, plus taxes and fees, if applicable. You will continue to be responsible for all charges assessed by your local utility for all services it provides, including any other fees or taxes specifically associated with services it continues to provide during the term of this Agreement.
<b>Statement Regarding Savings</b>	The supply price may not always provide a savings.
<b>Contract Start Date</b>	The Term of this Agreement will begin on the date your local utility processes your enrollment with XOOM Energy.
<b>Contract Term/Length</b>	This is a 36 month Agreement
<b>Cancellation/Early Termination Fees</b>	If you cancel this Agreement early, you will be responsible for paying a cost recovery fee ("Cost Recovery Fee") of \$200 which is intended not as a penalty, but simply to offset the cost of selling the unused portion of your electricity to others and estimated lost revenue that XOOM may incur from such a sale, if any, and related expenses.
<b>Renewal Terms</b>	XOOM Energy can renew this Agreement with new or revised Terms. No later than forty-five (45) days prior to the end of the initial Term, XOOM will send you a renewal notice describing your renewal options, in the event XOOM elects to renew this Agreement. This Agreement will automatically renew at the fixed rate or variable rate then in effect in accordance with the notice.
<b>Rescission</b>	You may cancel your acceptance of the Agreement with XOOM Energy by calling XOOM's Customer Care Center at 1-888-997-8979 or by sending an email to <a href="mailto:customercare@xoomenergy.com">customercare@xoomenergy.com</a> . You have three (3) business days from the start of your rescission period to rescind this Agreement without penalty. The start of the rescission period will depend on your method of enrollment as follows: (1) for written contracts, the rescission period will begin when you sign the contract; (2) for electronic enrollments, the rescission period will begin when you submit your enrollment; and (3) for telephone enrollments, the rescission period will begin when you receive the copy of your contract and contract summary (by electronic mail or U.S. Mail).
