<b>Renewal Terms</b>	<p>Subject to governing law, XOOM can renew this Agreement with new or revised Terms. No later than forty-five (45) days prior to the end of the term, XOOM will send you renewal notices, at least two, describing additional service plans for your consideration, in the event XOOM elects to renew this Agreement. If you decide not to choose a new service plan upon the expiration of the term, this Agreement will automatically renew at a variable rate that will continue on a month-to-month basis, in accordance with the notices.</p>												
<b>Cancellation/Cost Recovery Fee</b>	<p>You may cancel this contract at any time, but there may be a Cost Recovery Fee that applies if you cancel your contract prior to the end of your contract term. If you qualify for the flat monthly charge, there is a Cost Recovery Fee of \$100.</p>
