Your rate may be higher or lower than the EDC's price in any particular month. There is no limit on the price for electric generation sold under this agreement, and there is no limit on the amount that your price can decrease or increase from month to month. <u>There is no cap on your variable rate, and there is no limit on how much the price may change from one billing cycle to the next.</u> You will receive notice of variable prices changes when the price takes effect (i.e. when you receive the bill with that price). |
