If you do not advise XOOM by the specified date, this Agreement will automatically renew at the fixed rate or variable rate then in effect in accordance with the notices.					
Cancellation/Early Termination Fees	If you cancel this agreement prior to the expiration of the 12 month term, you will be responsible for paying an early termination fee of \$110.
