



## XOOM Energy Pennsylvania, LLC Electric Generation Supplier Contract Summary

This document summarizes the key terms of your contract with **XOOM Energy Pennsylvania, LLC** (“XOOM”). You have chosen XOOM as your electric generation supplier. XOOM is not affiliated with your electric distribution company (“EDC”). XOOM’s charges for electric supply will appear on your utility bill separate and apart from your EDC’s charges for delivering your electricity. Your EDC will continue to deliver your electricity, read your meter, send your bill, and make necessary repairs.

<b>Price Structure</b>	<p>Your rate for electric power purchases will be a <u>variable rate, per kilowatt hour</u>, that may change on a monthly basis, plus taxes and fees, if applicable. Your rate is based upon a number of factors, which may include but not be limited to, the fluctuation of wholesale commodity costs or other components of wholesale prices (including but not limited to capacity related costs, fluctuations in energy supply and demand, and weather patterns) and XOOM’s pricing strategies. Your rate may be higher or lower than the EDC’s price in any particular month. There is no limit on the price for electric generation sold under this agreement, and there is no limit on the amount that your price can decrease or increase from month to month. <u>There is no cap on your variable rate, and there is no limit on how much the price may change from one billing cycle to the next.</u> You will receive notice of variable prices changes when the price takes effect (i.e. when you receive the bill with that price).</p>
<b>Generation/Supply Price</b>	<p>Your initial rate under this contract is \$0.0699/kWh. This initial rate will be in effect for 3 months, and thereafter, your rate will vary month to month based on the factors described above.</p>
<b>Statement Regarding Savings</b>	<p>XOOM’s variable rate for electricity supply may be higher or lower than your EDC’s price in any particular month, and there is no guarantee of savings</p>
<b>Deposit Requirements</b>	<p>XOOM does not require any deposit</p>
<b>Contract Start Date</b>	<p>The Term of this Agreement will begin with your first meter read by your local utility following your enrollment with XOOM</p>
<b>Contract Term/Length/Renewal</b>	<p>This is a month to month contract</p>
<b>Cancellation/Early Termination Fees</b>	<p>You may cancel this agreement at any time, with no cancellation fees, by providing 15 days written notice to XOOM</p>
