Generation/Supply Price	You'll receive an introductory electricity supply price of \$0.1019 per kWh for your first 2 bills and your price will be variable after that. The initial price after the introductory period expires will be \$0.1019. Thereafter , the price can change each month and will be shown on your monthly bill. We will not provide advance notice of any price changes. This does not include the price that your electric utility will charge you for the delivery component of your electric service.
