We will supply your electricity under this contract, but your utility will continue to be responsible for delivering your electricity and sending you a bill for both of our services. This contract may be referred to as the "Terms of Service" or "Disclosure Statement."

Generation/Supply Price	You'll receive a fixed electricity supply price of \$0.1019 per kWh for your first 6 bills. This does not include the rate that your electric utility will charge you for the delivery component of your electric service.

Contract Start Date	We will begin providing service to you after your utility processes our request to switch your service, which occurs within 10 days from the date you agreed to switch.
Contract Duration	This is a 6 month contract.
Cancellation/Early Termination Fees	If you cancel your contract prior to the end of its Contract Duration indicated above, an early cancellation fee of \$250 applies. Note: If you cancel after you receive the second renewal notice from us and before the expiration of the contract, there is no fee. There is also no fee if you cancel during the variable price portion of any contract. We may decide not to collect applicable fees.
End of Contract	If you have a fixed duration contract that will be ending, or whenever



	XOOM want to change the contract, you will receive two separate notices before the contract ends or the changes happen. You will receive the first notice 45-60 days before, and the second notice 30 days before the expiration date or the date the change becomes effective. These notices will explain your options. If you do not cancel the contract or switch to another provider before the expiration of your contract, your service will continue at the price and contract duration indicated in the second notice.
Right of Rescission	You have 3 business days to rescind this contract by contacting us at the telephone number or email address listed below. This is called your "Right to Rescind" period, which means you will not start service with us until after this period.

Note on Dispute Resolution: This contract limits the circumstances under which you can bring a dispute to court, and does not permit class actions or a jury trial. Review the section "Arbitration and Waiver of Jury Trial" below for details.
