We appreciate your business. This document is a contract between us, XOOM Energy Pennsylvania, LLC, and you that allows us to switch your electricity account(s) to our service or to continue service. We will supply your electricity under this contract, but your utility will continue to be responsible for delivering your electricity and sending you a bill for both of our services. This contract may be referred to as the “Terms of Service” or “Disclosure Statement.”

| Deposit Requirements | <p>None</p> |
| Incentives | <p>XOOM will donate the equivalent of 5% of monthly energy charges paid by participating customers to PetSmart Charities, Inc for its general charitable purposes. This contribution is not tax deductible.</p> |
| Contract Start Date | <p>We will begin providing service to you after your utility processes our request to switch your service, which occurs within 10 days from the date you agreed to switch.</p> |
| Contract Duration | <p>This is a 12 month contract.</p> |
| Cancellation/Early Termination Fees | <p>If you cancel your contract prior to the end of its Contract Duration indicated above, an early cancellation fee of \$110 applies. Note: If you cancel after you receive the second renewal notice from us and before the expiration of the contract, there is no fee. There is also no fee if you cancel during the variable price portion of any contract. We may decide not to collect applicable fees.</p> |

| End of Contract | If you have a fixed duration contract that will be ending, or whenever XOOM want to change the contract, you will receive two separate notices before the contract ends or the changes happen. You will receive the first notice 45-60 days before, and the second notice 30 days before the expiration date or the date the change becomes effective. These notices will explain your options. If you do not cancel the contract or switch to another provider before the expiration of your contract, your service will continue at the price and contract duration indicated in the second notice. |
| Right of Rescission | You have 3 business days to rescind this contract by contacting us at the telephone number or email address listed below. This is called your "Right to Rescind" period, which means you will not start service with us until after this period. |
