Price Structure	Your rate for gas purchases will be a fixed rate, per therm, plus taxes and fees, if applicable. A fixed rate is a rate that is set at a fixed price, per therm, that is established at the time of your enrollment under this Agreement and remains the same for your Contract Term/Length. A variable rate is a rate, per therm, that may change on a monthly basis and may fluctuate based on weather patterns.
Generation/Supply Price	Your fixed rate under this contract is \$0.6390/therm.
Statement Regarding Savings	XOOM's fixed rate for energy may be higher or lower than your GDC's price in any particular month. There is no guarantee of savings.
Time required to change from TPS back to default service or to another TPS	If you call to cancel service with XOOM, the estimated time required to change from XOOM to default service or to another TPS is one to two billing cycles.

Right to Cancel/Rescind	You will have seven (7) calendar days, starting from the date of your EDC's confirmation notice, to contact the EDC and cancel this contract.
Contract Start Date	The Term of this Agreement will begin with your first meter read by your local utility following your acceptance into the program.
Contract Term/Length	This fixed rate contract will be in effect for 12 months, and thereafter, your rate will be based on the Renewal Terms described below.
Cancellation/Early Termination Fees	If you cancel this Agreement early, you will be responsible for paying a Cost Recovery Fee of \$110.
Renewal Terms	No later than thirty (30) days prior the end of the term, XOOM will send you a renewal notice describing additional service plans for your consideration, in the event XOOM elects to renew this Agreement. If you decide not to choose a new service plan upon the expiration of the term, the price for gas provided under this Agreement will become a variable rate as described in your renewal notice, and you will continue to receive gas supply from XOOM on a month-to-month basis until terminated by either you or XOOM.
